# 1 Delay

This issue of the Industry Report has been delayed by a month. We are sorry about that. However, we have been busy in the meantime. This is what we did

APTECAPP	The spreadsheet <b>App</b> which was uploaded last October needed a text companion. Originally we had placed a document called <b>Step-By-Step</b> which needed serious updating as it was created in August 2005. We have revised and uploaded the new version.
CLIENT BASE	In the past Aptec would not offer consultancy services to projects that proposed to source equipment entirely from local vendors. Such promoters invariably got stuck when they sought to expand beyond 3000 BPH, which was the limit of local suppliers' support. The client had to sell his plant and begin afresh with a standard overseas supplier who could support his growth fully. Backing such projects with no clear growth path held no professional satisfaction for a consultant, we felt.
	Aptec will now work on projects supported by RND and Storm Engineering either with the vendor or the promoter, depending on what the latter wants. <b>RND</b> has tied up with <b>Baader-Linco</b> and <b>Storm</b> has likewise the help of <b>Dutch Poultry</b> and so both are able to offer full hand-holding for growth to their clients. Aptec will, however, not involve itself in project sale for any vendor.
HANDBOOK	We have now added a new feature to our webpage. A project design <b>Handbook Project</b> . We will progressively upload chapters of this handbook. The proposed chapters have been listed and we have two uploads – on <b>chilling poultry</b> and on designing <b>rendering plants</b> . We expect to complete this project before 2023 end. You may download the handbook free of cost.
INDUSTRY REPORT	We are discontinuing the technical reviews and database in the Industry Report. Some of the past technical articles will now be updated and included in the Handbook chapters.

# 2 Schedule

When this Industry Report was uploaded, the earlier Report dated March 2021 was taken down. We now follow the policy of maintaining four consecutive bi-annual Reports at any time on our website. # 3 Developments In The Industry

Two plants have shut down for the time being because of pressure from their banks. Indian banks have of late tightened their collections and recovery drive against loans following conscious policy measures taken by the government to reduce non performing assets (NPA). These are Arambagh Hatcheries and Hybro. We understand efforts are on to restore them to health.

CP is learnt to have exited several regional markets and to have stopped getting birds processed by Penn Foods and ProTAC. We understand that their commercial broiler production has also been curtailed and production at their Chittoor plant has been reduced to just cover captive needs to keep their retail RTE operation Five Star Chicken running.

### 3.1 Breeds

In recent years some changes have happened in the broiler breeds space. Suguna, who had worked with Cobb from VH, then Ross with Aviagen, then Hubbard, finally ran out of options when Hubbard was acquired by Aviagen. Of late Suguna has developed its own breed carrying the name of **Sunbro**. At present this breed is learnt to have reached a DOC placement of around 500 million a year. Sunbro is said to be a red, heat-tolerant bird and in this regard said to closely resemble the dominant breed from VH. Heat-tolerance suits the essentially open commercial shed farming makeup of the industry in India. One of Sunbro's GP lines comes from a breeding company in Hyderabad.

This calls to mind earlier experiments carried out in India, with limited success. There was the case of a breed called **Hubchix**, promoted by **C&M** of Nasik and **Kasila**, the latter promoted by the Hyderabad based breeding company of **Sheikh Imam**. Both of them closed down in the early years of this century. The principal reason was the absence of a *true and stable pure line*.

# 3.2 Corporates Specializing in Building Processed Broiler Brands?

Hiding behind dry and uninteresting statistics that Aptec's Industry Report publishes twice every year, are trends that may be very valuable for existing players and future investors – both Indian and overseas. In this Report we bring two such trends to your notice. The first is the sharpening focus of broiler corporate houses towards establishing their brands.

After over a decade of experimentation, (ignoring for the moment those multi-location ventures that have not pursued their intentions boldly), some broiler industry players have arrived at the inevitable conclusion that multi-location processing operation and promoting a national brand of processed broilers is the only way to go. Which players are we talking about? Table 1 lists them.

What are the requirements for establishing a national brand? You must have farming operations in various zones. Then you should set up processing in each such zone. Promote your brand and connect directly with the consumer. In this way broiler epidemics do not seriously damage your brand because you have created for



yourself brand-friendly disease-proof-zoning (as against farm-zoning which got lost in endless parleys). It also indicates your awareness that to the consumer you sell FMCG, not livestock.

The pity is that none of these ventures have examined the *Hub & Spoke Model* seriously. Setting up 3000 BPH plants in several locations is not the way to go. You get no benefit of scale economies at such low capacities.

## 3.3 What is the Future of Foreign Interest in India's Broiler Industry?

A likely question to be asked these days is the prospect of overseas interest in the broiler business in India. Particularly so, against the backdrop of wholesale exit of businesses from China. Does India have a convincing story to tell? We have been watching this for nearly a quarter century and have much to tell. At least, we do feel it our duty to record past attempts in this general direction and let you form your own opinion. Unlike other industry sectors such as automobiles, electronics, energy, engineering, infrastructure, IT and pharmaceuticals, the livestock industry poses many more challenges.

The first among these is the absence of statistics, records and reporting – many of livestock industry's subsectors still reel from the ill-effects of agriculture being non-taxable and therefore a magnet for the informal economy. There remains a confusion about definitions – at what stage does farming transform into industry, a fact which needs clarity if we are to follow the government's directive to process more and more of our farm produce. And finally how, in the absence of public domain reporting of outputs strictly enforced by the government, can India's monopolies and restrictive trade laws be implemented? And that, by a judicial system distracted from its true role, to justify dynastic continuity for past and present judges in Indian high courts!

Finally, livestock industry is not uniform all over the world. There are local climatic, behavioral and consumer factors to look into. Indians do not farm and process just like Americans do! We do not farm and process even like south east Asians do! Our way is different, and has had success - we have not done badly for ourselves!


